Adjustments for Futures Contracts:

Base price of the Futures contracts on February 03, 2023 will be reference rate less aggregate amount of dividend i.e. Rs. 12.50 /-. The reference rate to be reckoned for this purpose shall be the daily mark to market settlement price of the relevant futures contract.

Adjustments for Options Contracts:

The full value of dividend i.e. Rs. 12.50 /- would be deducted from all the cum-dividend strike prices on the exdividend date. The details of the old and corresponding new options contracts that shall be available for trading from February 03, 2023 would be notified on February 02, 2023.
