Adjustment of Futures and Options contracts in the security VEDL

VEDANTA LIMITED has informed the Exchange that Board of Directors at its meeting held on November 22, 2022 has declared Interim Dividend of Rs 17.50/- per equity share of face value of Re. 1/- each. The record date for the purpose of payment of dividend is November 30, 2022.

Adjustments for Futures Contracts:

Base price of the Futures contracts on November 29, 2022 will be reference rate less aggregate amount of dividend i.e. Rs. 17.50 /-. The reference rate to be reckoned for this purpose shall be the daily mark to market settlement price of the relevant futures contract.

Adjustments for Options Contracts:

The full value of dividend i.e. Rs. 17.50 /- would be deducted from all the cum-dividend strike prices on the exdividend date. The details of the old and corresponding new options contracts that shall be available for trading from November 29, 2022 would be notified on November 28, 2022.

Members are advised to load the updated contract.gz file in the trading application before trading on November 29, 2022. This file can be obtained from the directory faoftp/faocommon on the Extranet server.
